



Securitisation for Major Russian Bank

Securitisation is the funding and risk transfer method for an increasing number of issuers and the largest growing contributor to the global capital markets. Working on behalf of a Russian banking group, we have securitised by means of a Luxembourg structure, Russian debt in excess of US\$1 billion. Our client has benefited from lower solvability ratio and enhanced liquidity.

Trusts for High Net Worth Client

Discretionary trusts are often used to pass on wealth from one generation to another. They can also be used as a suitable conduit for effective structuring especially when dealing between countries with favourable double tax treaties. We have set-up a number of Cyprus trusts for a client based in east Europe, and each trust deals with a particular sector of activity. Each structure has a number of Cypriot entities holding the investments and on top of them BVI, Belize and entities in other jurisdictions. The result is an overall tax efficient structure, secure and parts of which can be disposed or taken for listing easily.

Diamond Fund in Luxembourg and UCITS in Cyprus

For a German client owning diamond assets we have set-up a diamond fund in Luxembourg. We have proceeded to do requisite work for the SPV obtaining licences and list it in Euro MTF, Luxembourg's alternative stock exchange, thus obtaining liquidity of over US\$100 million. For the same client, we are in the process to set-up a UCITS fund in Cyprus with a market capitalisation of US\$150 million which will be later listed in one of the major EU stock exchanges.

Cyprus Investment Firms (CIF)

Oneworld Itd is a market leader in setting up and the provision of professional services to investment firms in Cyprus under the Financial Services Law in May 2004. Since the enactment of this legislation we have applied on behalf of 11 investment companies from Europe and obtained licences by the Cypriot regulator, the CySEC. We are currently doing the same for 5 investment companies.

Further, to assisting with securing the licence, we render on-going services which include internal audit, compliance, accounting, executive selection services as well as general advice for EU passporting.


Redomiciliation

Recently, we have redomiciled in Cyprus a number of companies registered in other jurisdictions. Redomiciliation opens new planning dimensions for investors and traders. Foreign companies may now gain the powerful benefits provided by the Cypriot corporate regime which include dividend income tax and capital gains tax exemptions, the absence of withholding tax for income distributions, an extensive network of double tax treaties, no CFC or thin capitalisation rules and many more.

There is no need to restructure and transfer assets and liabilities to a nearly incorporated Cyprus company followed by a liquidation of the entity.

Management and Control in Cyprus

For a German high net worth client we have proceeded to restructure his activities and render Cyprus as "the place of effective management". This is required to make sure that the Tax Authorities of other countries with which he works do not have a claim over profits realised.

We have advised on the steps to be undertaken which included the setting up in Cyprus of branches of foreign companies, arranging the composition of company board of directors, signing contracts in Cyprus holding board meetings in Cyprus. We also advised that any non-Cyprus tax resident directors should not be vested with power to override the board's decisions.
